- (6)For starting the pre-primary school (Nursery/LKG /UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- Any other conditions that may be imposed in future. (7)
- Government of Karnataka may take action to withdraw this No (8)Objection Certificate in case any of the conditions is violated.
